



As the last official month of summer winds down, we in Florida know that there is plenty of heat to come for us, along with the real heart of the hurricane season. Although we have had some rain to break the drought which spawned so many wildfires, with our own beleaguered Santa Fe Swamp again suffering a near total burn, we are still way below normal rainfall amounts; our lake levels are a most obvious reminder of that. But as bad as it may seem to us, our friends on many surrounding lakes are in far worse shape. At long last, the MFL Prevention/Recovery stakeholders group for some of these area lakes is finally getting underway (please see related article). SFLDA has been at the forefront in making this happen, and we will continue to take an active role in the process. The drawdowns in our aquifer and lakes are a complicated and long-term problem and there will be no simple solutions.

Recovery & MFL Meeting

The Clay-Putnam **minimum flows and levels** prevention/recovery strategy development stakeholder group met at the St John's Water Management District headquarters in Palatka on Aug 11. The meeting focused on lakes Geneva, Brooklyn, Cowpen and Grandin.

Brooklyn, Cowpen, Geneva, and Grandin are not projected to meet their MFLs under 2030 water projections. Brooklyn, Cowpen, and Geneva, specifically, are not meeting their MFL under current water use demands, thus triggering "recovery". Grandin is projected to cross the "trigger" threshold in the future and so will be in "prevention" mode. These four lakes are part of the Prevention and Recovery strategy.

This ongoing series of meetings is designed to address the MFL's and the structure and function of the various stakeholder groups who will be participating in the determination of strategies designed to implement recovery of area lakes.

Santa Fe Lake Dwellers Association will have a technical committee seat along with other stakeholders such as agriculture, water utilities (JEA/GRU), recreation, environmental groups, homeowner associations and the City of Keystone Heights, among others. It is very important for your association to have representation because Suwannee River Water Management District, Lake Santa Fe, and our area are all directly affected by the decisions that are made by this group and both water management districts.

The dates and times of the future MFL strategy meetings will be posted on our website, www.lakesantafe.org. Public access is required for these meetings, so don't hesitate to attend if you are able.

Just a few of SFLDA Successes:

Led the fight to prevent Georgia Pacific from draining and mining the Santa Fe Swamp for its peat.
◦

Halted plans for construction of a huge commercial development with high-rise boat storage, 100 overnight rental units, and a sewage treatment station.
◦

Effectuated the removal of tons of illegal fill and the restoration of many acres of damaged wetlands in Santa Fe Pass and Gator Cove.
◦

Worked with Melrose Bay Property Owners Assoc. and People for Alternatives to Landfills to prevent the construction of a landfill near Orange Heights.
◦

Obtained a Florida Forever grant for the purchase of nearly 11 thousand acres of wetlands and uplands to protect the water and health of the entire Santa Fe Lake and watershed.
◦

Educational outreach – published and disseminated the booklet, Here Today, Here Tomorrow, The Lake Lovers Guide to the Santa Fe Lakes.
