

Letter from our President

Greetings Lake Dwellers and Friends,

What a summer we're having! After the rainiest July ever recorded, our lake levels are very high, hovering around, or above, our Ordinary High Water mark of 141 feet. This has made the lake accessible to a wide variety of users, making Lake Santa Fe a very popular place these days. We hope you all are busy making happy summer memories.

Summer is also the time for your lake community to come together for the Santa Fe Lake Dwellers Annual Membership Meeting, where we elect our Board of Directors for the upcoming year and catch up on the latest news in our area. We will convene at 7 PM on August 16th, at the Yerkes Parrish Hall of Trinity Episcopal Church in Melrose, our traditional meeting place for many years. Our speaker this year is local biologist and world-renowned cave diver Tom

Morris. His presentation will be of keen interest to all in our area who love our lakes and would like to learn more about them. Tom's knowledge of Florida's aquifer system has been gained by many years of exploring and documenting what to the rest of us remains the great unknown, and we look forward to learning more about this mysterious world from a real inside man.

Regardless of the welcome rainfall, the state of our aquifers, both in quantity and quality, remains a critical concern to us in North Florida. Blessed as we are at Lake Santa Fe to have 'a good bottom' (clay layer beneath us), the results of the cumulative aquifer drawdowns in recent decades can most visibly be seen in local sandhill lakes Geneva, Brooklyn, Swan, and Cowpen. Our Board continues to work with our neighbors and local water management districts in an attempt to understand and alleviate this downward spiral. The health

of our lakes is directly connected to our most basic human need (and right!) for adequate, clean water. Please see Board member and Legislative Chair Terry Brant's article about Minimum Flow Levels (MFLs) and water policy. As always, Terry gives us insight into the confusing, and often infuriating, world of water management in Florida.

It is with mixed feelings that we are suspending our LakeFest and Clean-up (see article). We just did not feel that the expense was justified. It has been a labor of love for 14 years, at the same time greatly rewarding and extremely exhausting! Thanks to all for your participation, especially to those who worked so hard to make it a success ...you know who you are!

Do you realize that our mailings go out to over 700 households around the Santa Fe Lakes? Our active membership is only a fraction of that number, but we've always felt it important to keep all 'lakeys' informed. Each mailing is a big expense to our organization, and we need our lake residents' support to continue serving our huge lake family. Minimum Flow Levels

Santa Fe Lake Dwellers has serious concerns regarding the future sustainability of our water resources: with most of the St. Johns Water Management District (SJRWMD) in a planned water caution area, lakes below Minimum Flow Levels (MFL), forecasts for increasing water withdrawals, and District warnings of being unable to meet or maintain MFLs over the next twenty year period, the need for expeditious action and an effective long-term and substantial regional aquifer renourishment project to protect, recover and restore our resources, and mitigate the damage caused by the adverse

effects of previous and planned consumptive use permitting, must be responsibly addressed and implemented.

SFLDA has strongly objected to St. Johns' plan to dramatically lower MFLs on Lakes Brooklyn and Geneva, in particular the new infrequent lows, which we believe will be harmful. We have made several presentations requesting that the proposed MFLs not be adopted. Recovery or prevention strategies on nearby lakes and the aquifer that ultimately affect Lake Santa Fe and the Suwannee District should be successfully implemented using current set MFLs, with a long-term

plan in place in order to give the lakes maximum protection and the opportunity to achieve recovery or prevention.

Adopting new, significantly lower MFLs that are clearly less protective, promoting longer periods of low water levels when the lakes are already endangered due to low water, appears to be absent any recognition of "public interest" or modeling recognition of the actual damage and loss of protection the proposed lowered MFLs will provoke.

Santa Fe Lake Dwellers is dedicated to protecting and restoring our endangered resources.

Rural Cluster Update

Some of you will remember the recent attempt by the Painter family to extend the current boundaries of the Rural Cluster in order to put in a development just west of Melrose. Many local groups and individuals spoke out to the Alachua County Commission (BoCC), and we succeeded in derailing this scheme for the time being.

But now this issue is back on the table, in a form that will affect all 13 of Alachua County's Rural Clusters. Briefly, the County Planning Dept. is proposing changes in the Comprehensive Plan's language which will "simplify the process for delineating more precise boundaries for Rural Clusters". You can get a detailed look at all the relevant documents by following the link at the end of this article.

Having only recently learned of these complicated rule changes, the Santa Fe Lake Dwellers Association believes that this proposal should be delayed for at least a couple of months to give people the opportunity to understand this issue. This would give time to meet with folks from the areas to be impacted and find out if these changes in the Comp Plan are desirable to locals. Public input should be invited now, in case the rural communities to be impacted decide they do not approve of the proposed "parcelbased boundaries" system. The BoCC will take up this issue on Aug 13th, and the SFLD Board plans to be at that meeting to request a delay in moving forward with these proposals until public informational meetings have been held.
